Lastly, in the Supplementary, the first sentence of the "Evaluation of the model" was "The refined model achieved a Cohen's kappa score of 0.667 (0.605, 0.749) and an accuracy of 0.811 (0.787, 0.853) on the CAPTURE-24CN dataset".

The correct statement should have been: "The refined model achieved a Cohen's kappa score of 0.674 (0.614, 0.743) and an accuracy of 0.814 (0.783, 0.851) on the CAPTURE-24CN dataset."
